

TERMS & CONDITIONS - HEALTHY BsB 2020

dated 19.09.2020

Due to the pandemic we decided to host the evening as follows:

The **Healthy-BsB** takes place in compliance with the **hygiene measures of the state government of Hesse**. Under the rules set on 15.08.2020 the evening is as follows:

- Max. 40 attendees, separate dance rooms, safety distance
- Registration with a questionnaire, which will be secured and kept for up to 1 month after the event before being destroyed as requested by hessian government
- no party entries
- a special practice facility at the end of all workshops with music in 2 separate rooms
- no partner change during class
- during the practice facility, on a voluntary basis a free partner change up to a maximum of 10 dancers is possible. This wish must be known in the registration: "first comes, first served"

Due to the pandemic we are obliged to consider the following 3 scenarios until 28.11.2020 in accordance with Hessian government:

1) Ban of events:

Cancellation of the **Healthy BsB** with a 100% refund

2) enforced measures will result in adjustments by:

e.g. partner change canceled;

e.g. partner change reduced to 5 dancers, then priority in the registration applies;

e.g. increased distances resulting in reduction of number of attendees, then priority in the registration applies

3) Further relaxation. Even so, the number of attendees is limited to 40, party entries are still forbidden and partner change only permitted during practice facility. The relaxed measures will only apply to the practice facility:

e.g. increased number of dancers for partner change (currently limited to 10) in a separate room

e.g. hold a party instead of a practice facility

Despite the scenarios you also agree to the following:

- first comes, first served rule applies throughout the evening
- register for the class your level suits the best so all dancers smile happily
- to wear a mask if you are not within your dancing slot and keep the required distance from other attendees
- to follow the safety instructions of the BsB-Team throughout the evening
- the registration is at the same time the mandatory questionnaire to be secured and saved up to 28.12.2020 for back-tracing should any Covid-infection appear
- by registering you hereby agree to the **terms and conditions**, the **GDPR** and latest **hygienic rules** set by the [Hessian government](#)
- should an attendee be present despite Covid-warnings and thereby an infection occur within the evening the organizer as all other attendees are eligible to take legal actions against that attendee
- no refund in case of last minute cancellation by participants
- no refund in case of last minute replacement of a teacher by another
- BsB Organizers take no responsibility in case of thievery and recommend to only bring the necessary garments useful for the dance

To prevent any misfortune, all attendees agree to behave in a mindful, respectful, safe and secure manner so more dance events could be possible in the future
